# MADE IN ITALY - PROFESSIONAL USE PRODUCT

**PROFILE AND INTENDED USE:** FRAGMENTI EASYCARE is the result of careful research using a new generation of silane fluorinated acrylic copolymers with unique hydro-oil repellent characteristics, for the protection of surface materials. It guarantees a longer duration of the product and excellent protection of the treated support. FRAGMENTI EASYCARE is a protective product for floors, walls, kitchen back-splashes and shower walls decorated with Fragmenti Cotto material. FRAGMENTI EASYCARE can be used also as protective for floors and walls and benchtops in unglazed klinker, concrete, plaster and in all non-polished natural stones (porphyry, marble, granite, slate, travertine and sandstones). The treatment used on the outside gives the surfaces subjected to heavy traffic a strong resistance to abrasion. **IMPORTANT:** Before using the product make sure that the manufacturers of the materials do not advise against its use.

**INSTRUCTIONS:** Shake before using. Operate with temperatures between + 10 ° C and + 30 ° C. Avoid applying the product on very hot surfaces, during strong wind or possible rain. For the application of FRAGMENTI EASYCARE you can use a spreader fleece, cotton cloth or brush. On vertical surfaces apply the product wet on wet, on floors instead wait 30-60 minutes between one application and the next. On kitchen back-splashes and shower walls an additional coat may be required. In any case, protect the product for at least 24 hours after finishing the application. FRAGMENTI EASYCARE can be applied as a final coat or can be completed with FRAGMENTI EASYWAX treatment for a stronger protection and easier regular maintenance.

**MAINTENANCE:** For routine cleaning use neutral detergent.

**ALWAYS RUN SOME TEST APPLICATIONS BEFORE APPLYING IT TO THE DEFINITIVE SURFACES.**

**DILUTION:** Ready to use.

**YIELD:** Approximately 15-25 sqm/l per coat.

**STORAGE:** Closed in the original packaging, in a cool place, away from frost and UV rays, it retains its properties for at least one year.

**HEALTH:** The product is not classified as hazardous pursuant to the provisions set forth in EC Regulation 1272/2008 (CLP) (and subsequent amendments and supplements).
